Description of requirement

Additional Contract Conditions (*Zusätzliche Vertragsbedingungen* – ZVB)**1. General**

- (1) The following contract conditions and the General Terms and Conditions for the Execution of Services (*Allgemeine Bedingungen für die Ausführung von Leistungen* – VOL/B) shall apply to the delivery of goods and performance of services.
- (2) The contractor's terms and conditions of supply, payment, and business shall only become part of the contract if this has been expressly agreed.

2. Prices

The agreed prices are market prices under Regulation PR30/53 on Pricing in Public Contracts (*Verordnung PR 30/53 über die Preise bei öffentlichen Aufträgen*) of 23 December 1953 (Law and Ordinance Gazette [GVBl.] p. 1511), as amended. The setting of prices is subject to PR 30/53 as well as review by the authorities responsible for pricing and price monitoring on the basis of PR 30/53.

3. Delivery

The contractor shall deliver to the collection point designated by the contracting authority at the agreed time free of charge.

4. Early payment discount

- (1) A deduction of 2% of the invoice amount shall be applied for payments made within 14 days of receipt of a verifiable invoice. Sentence 1 does not apply to services and goods for which discounts are prohibited by law, in particular for price-fixed publishing products.
- (2) Early payment discounts shall be applied to all payments (including payments according to the payment schedule, advance payments, payments on account, final payments, and partial final payments).
- (3) Paragraphs 1 and 2 shall not apply if otherwise agreed in accordance with point 17 of the Special Contract Conditions.

5. Requirement of the written form

Any amendment, addition, or deviation from the contract must be in writing in accordance with the requirements stated in Section 126b of the German Civil Code (*Bürgerliches Gesetzbuch* – BGB).

Special Contract Conditions (*Besondere Vertragsbedingungen* – BVB)

The following Special Contract Conditions are additions to meet the special requirements of the individual case. They relate only to the delivery of goods and performance of services that are the subject of this tender.

The tenderer must not make any changes or markings. The boxes may only be ticked by the contracting authority.

6. Communication

Unless otherwise agreed, communication, both written and spoken, between the contracting authority and the contractor shall be in German.

7. Price adjustment clause

Notwithstanding No. 2 of the Additional Contract Conditions, the following price adjustment clauses shall apply:

9. Subcontracts

In addition to Section 4 (4) VOL/B, the following is agreed:

- ☐ The contractor shall inform the contracting authority of the names, contact details, and legal representatives of the suppliers involved in service contracts at the latest when commencing performance of the contract
- ☐ The contractor relies on the capacities of subcontractors for the contract, and thus the contractor and subcontractor shall be jointly liable for the fulfillment of the contract with regard to economic and financial capacity. The contractor shall conclude a suitable agreement with the respective subcontractors.

via the federal government's Online Access Act-compliant invoice submission portal (OZG-RE), using the transmission channels offered.

17. Early payment discounts
